

# Apportionments - What Are They?


- The main way we support the ministries of the United Methodist Church
- A method of giving that proportionally allocates the churchwide budget to conferences and local churches
- Together, through our connected congregations, we accomplish what no single church, district or annual conference ever could hope to do alone. In this way, each individual, family, and congregation gives a fair share for the church's work.

# Apportionments: What Do They Pay For?

- Part of **our pastors' salaries & benefits** (via grants from different parts of Methodist church)
- Part of our pastors' pension
- **Ministries** at all levels of the United Methodist Church (local to global)
- Part of the **administrative expenses** for all levels of the United Methodist Church (local to global)

### **TPC Apportionment by Category**


#### Travis Park Church 2019 Annual Apportionment: \$93,417






District Ministries: \$6,203

# Las Misiones District Causes

- Funds held by the District, and used for office expenses and to fund any benevolent and mission causes.
   These funds are directly used & controlled by the District.
- Examples:
  - -helping local pastors & their course of study expenses
  - -Metro Mission board (grants up to \$8k to churches doing creative/high impact work)
  - -youth camps, campus ministries @ UTSA, SAC, Trinity, etc.

## Apportionments: Things to Consider

- Adverse affects of not paying apportionments
  - To Travis Park Church
  - To the conference
  - To many ministries, local to global
- In case of disaffiliation
  - Potential requirement to pay 2 years' worth of apportionments
- Deliberate / intentional ways to pay apportionments
- Downward trend for Rio Texas Conference apportionments

# Building Committee

### UMC "Trust Clause"

- "Premises shall be used, kept, and maintained as a place of divine worship of the UMC..."
- "Ownership" of TPC building would revert to Rio Texas Annual Conference if TPC ceased to be UMC congregation
- Trust clause found in original TPC deeds
- Legal challenge?

2503. Trust Clauses in Deeds—1. Except in conveyances that require that the real property so conveyed shall revert to the grantor if and when its use as a place of divine worship has been terminated, all written instruments of conveyance by which premises are held or hereafter acquired for use as a place of divine worship or other activities for members of The United Methodist Church shall contain the following trust clause:

In trust, that said premises shall be used, kept, and maintained as a place of divine worship of the United Methodist ministry and members of The United Methodist Church; subject to the Discipline, usage, and ministerial appointments of said Church as from time to time authorized and declared by the General Conference and by the annual conference within whose bounds the said premises are situated. This provision is solely for the benefit of the grantee, and the grantor reserves no right or interest in said premises.

### UMC "Trust Clause" - continued

6. However, the absence of a trust clause stipulated in §§ 1, 2, 3, 4, or 5 above in deeds and conveyances executed previously or in the future shall in no way exclude a local church ... from or relieve it of its connectional responsibilities to The United Methodist Church.

## Taylor Disaffiliation Plan

- New Section 2553 deemed "constitutional"
- Exit must be complete by December 31, 2023.
- Requires two-thirds (2/3) majority vote of the congregation present at church conference.
- "Terms and conditions for disaffiliation shall be established by the board of trustees of the applicable annual conference, with the advice of the cabinet, the annual conference treasurer, the annual conference benefits officer, the director of connectional ministries, and the annual conference chancellor."
- Requires simple majority vote of annual conference delegates

## Taylor Disaffiliation Plan – continued

### Disaffiliation Agreement:

• Apportionments

for the 12 months prior to disaffiliation, as well as an additional 12 months

Property

TPC would retain its real and personal, tangible and intangible property.
TPC would bear all costs for transfer of title or other legal work

• Pension Liabilities

TPC's pro rata share of any aggregate unfunded pension obligations

• Payment Terms

Payment shall occur prior to the effective date of departure.
